- confirm the author's willingness to present the paper/poster if it is selected
- identify the intended presenter if multiple authors are listed

The extended deadline for receipt of abstracts is 30 June 2010. Abstract should be submitted electronically only via www.fib2011prague.eu.

Authors of selected papers/posters will be notified of acceptance from the Symposium Scientific Committee by 31 August 2010. Final full-length (for Symposium DVD) and short-length (for printed Proceedings) papers/posters are due 11 January 2011. All the papers/posters will be reviewed by the Scientific Committee again for the final acceptance.



PRAGUE

Prague, with its 2000 year history, is one of Europe's most beautiful cities. The memorable sights of Prague include the Prague Castle and the St. Vitus Cathedral, the Charles Bridge, the Old Town Square with its famous Jewish Quarter with its old and new synagogues and the old cemetery, the Loreta and the National Theatre. The display of the Prague bridges spanning the river Vltava represents an extraordinary gallery of the masterpieces of the Czech builders and engineers since the 14th century to the present time. Prague already hosted the VIth FIP Congress in 1970 and the first fib Symposium in 1999 both with a great success.

VENUE

The Czech Concrete Society (Česká betonářská společnost – CBS) was established in 1993, originally as a spontaneous association of engineers active in the field of concrete and concrete structures. After six years of more or less voluntary activity it assumed in 2000 the legal status of a non-profit civic society, acquired legal personality and professional management. The resulting process of rapid development of its activities has been accompanied with a corresponding rise of its domestic reputation and its current distinction also on the international level. CBS is active in the global fib and IABSE, in the European ECSN network and in the Central European CCC Initiative. At present the CBS has 110 collective and 220 individual members, and the numbers continue to rise.
